- (h) All the recruitments against Open Advertisement Quota shall be at the minimum pay of the Level/scale of pay.
- {3} Period of reckoning sports achievements: Only those Sportspersons who have acquired the sports achievements eligibility norms in the championship on or after 01/04/2020 and are active will be eligible to apply for appointment against Sports Quota. For validity of sports achievement, concluding day of the championship/event shall be taken into account.
- 43 Age Limit: Minimum 18 years and maximum 25 years as on 01.01.2023 i.e must have been born not earlier than 02.01.1998 and not later than 01.01.2005. No age relaxation (upper age limit or lower age limit) shall be permissible.

- (i) For All Candidates except those mentioned in sub- Para (ii) below: DD (Demand Draft)/IPO (Indian Postal Order) of ₹ 500/- (Rupees Five Hundred Only) with a provision for refunding of ₹ 400/- to those candidates who actually appear in the trial.
- (ii) For candidates belonging to SC/ST/Women/Minorities and Economically Backward Classes: DD (Demand Draft)/IPO (Indian Postal Order) of ₹ 250/- (Rupees Two Hundred Fifty Only) with a provision for refunding the same to those candidates who actually appear in the trial and produce their original caste certificate and other requisite certificate.
- (iii) DD/IPO should be drawn in favour of "North Western Railway Sports Association", payable at Jaipur/G.P.O. Jaipur. Candidates are advised to fill DD/IPO details in application form in the space provided for the same.
- (iv) Minorities meaning Muslims, Christians, Sikhs, Buddhists, Jains and Zorastrians (Parsis). For claiming waiver of examination fee, Minorities candidates should furnish 'self declaration' as mentioned in Annexure-II along with Application Form, At the time of Trial/interview, such candidate claiming waiver of examination fee will be required to furnish 'minority community declaration' affidavit on non-judicial stamp paper that he/she belongs to any of the above minority communities. If 'self declaration' as mentioned in Annexure-II not enclosed with application or the affidavit is not produced during Trial, their candidature will be rejected.
- (v) Economically Backward Class (EBC) means those whose annual family income is less than Rs. 50,000/-. They have to submit income certificate at the time of applying in the prescribed format as given in Annexure-III on the letter head of the competent issuing authority.
- (vi) Fee in respect of candidates who are found ineligible shall not be refunded.

{7} Selection Procedure:-

i. Selection will be based upon Document Verification, performance in Sports Trials and assessment of sports achievement & educational qualification etc. Selection will be conducted by North Western Railway, Headquarter, Jaipur.





ii. After scrutiny of applications by the Scrutiny Committee short-listed eligible candidates will be called for Document Verification & Trial of sports performance. Candidates who will found suitable in Document Verification by Document Verification Committee, Trials of those candidates will be conducted by Trial Committee. Trial Committee conduct trial to assess their sports performance and suitability for Railway/Unit team as well as Indian Railways team. Trial Committee shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage, by giving marks as per the criteria given below:-

For Game skill, physical fitness & coach's observations during trials	40 Marks
FIT Candidate	Candidate securing 25 marks or more
NOT FIT Candidate	Candidate securing marks below 25

- iii. After Trial only the FIT Candidates in trial shall be considered for the next stage i.e. assessment of sports achievement & educational qualification by the Recruitment Committee.
- iv. Recruitment Committee shall award the marks (out of 60 marks) only to the FIT candidates for their sports achievements, educational qualifications etc. Candidates declared 'NOT FIT' will not be assessed further by the Recruitment Committee.
- v. Assessment of sports achievement & educational qualification of the FIT candidates shall invariably be held on the same day, just after trials or at the most, next day of the trials.
- vi. Recruitment Committee is to add the marks given by the Trial Committee to the FIT candidates (i.e., out of 40 marks), in order to make the final merit list (out of 100 marks.)
- vii. <u>Distribution of Marks</u>: Maximum marks which can be awarded by the Trial Committee for performance during Trial and Recruitment Committee during assessment of sports achievement & educational qualification, shall be as follows:

{8} Important Instructions:

Candidates fulfilling the eligibility criteria should submit their application form in good quality A/4 size paper in prescribed format as Annexure-I given in notification duly completed in all respects with self attested photo copies of necessary enclosures (certificate of age, education, sports achievements, caste/community, Minority, Economically Backward Class (EBC) etc.)

(ii) Application must be filled up by candidates in their own hand writing completely either in Hindi or in English language using blue/black ball point pen only.

Candidate should write his/her name, father's name/husband's name in capital letters as given in Educational Certificate. Candidate should also indicate other particulars as have been asked in the application form. Do not leave any column of the application form blank otherwise the application will be rejected.

One recent passport size colour photograph (4cm x 5cm), should be affixed on the application form without fail. The Photo may preferably not be older than 3 months as on the date of applying. The photo should clearly reveal the full face, should be sharp and clear. Passport size colour photograph affixed on the application form must not be with sunglasses, coloured glasses or cap and also not a photocopy of the photograph, otherwise the application will be rejected.

- (v) Signature of the applicant must be full and in running hand, not in block/capital letter or disjointed letters. Candidates are required to sign in English or in Hindi in the prescribed places provided in the application form, otherwise application will be rejected.
- (vi) Candidate must put the thumb impression of the left hand at the given place in the application form. If Left Thumb Impression (LTI) not affixed/blurred/ smudged, on the application form, the application will be liable to be rejected.
- (vii) Candidate should clearly indicate the specific sports discipline & event/position/weight category applied for as given in Para 1 above (like as e.g. 100 Mtr. Sprint/10 Mtr. Air Rifle e.t.c)
- (viii) Applicant should possess requisite educational qualification and sports achievements before the submitting the application.
- (ix) Candidates belonging to SC/ST/Minorities/Economically Backward Class, claiming for less fee as mentioned in para 5 (ii), must attach self attested photocopy of requisite Caste Certificate/Minority Certificate or self-declaration/Income Certificate. Otherwise their candidature will be summarily rejected.
- Sportspersons having sports norms for higher Pay Level/Grade Pay who have applied against the vacancies for the lower Pay Level/Grade Pay, will be considered for applied level only.
- (xi) Candidate applying for more than one game/event shall submit separate applications with separate DD/IPO as fee and documents for each event.
- (xii) Candidates serving in any Centre/State Government Department including Railways or Public Sector Undertaking should apply through proper channel or should apply directly to the RRC with NO OBJECTION CERTIFICATE from the employer to avoid delay. The last date of receipt of applications in the office of Railway Recruitment Cell will not be extended on account of any delay in transmitting the application by the office concerned. Advance copy of the application without No Objection Certificate will not be entertained. Applications received after closing date and time will also not be accepted.
- (xiii) Applications not fulfilling any of the terms and conditions given in this notification shall be summarily rejected.
- (xiv) Candidates should be in readiness to appear for the Trials etc. at short notice after the last date for submission is over.
- (xv) The list of Eligible/Ineligible candidates for the trial will be uploaded on the website of Railway Recruitment Cell, Jaipur. Call letters for Trial will be sent to the eligible candidates for appearing in the trial at their correspondence address and the schedule of the trial will also be uploaded on the official website (website address www.rrcjaipur.in) of Railway Recruitment Cell, Jaipur.
- (xvi) Candidates must bring all documents attached with application form & other requisite documents in Original along with one set of **self attested** photo copies on the day of trial, without which they will not be allowed to appear in the Trial. Certificates in languages other than English or Hindi should be accompanied by a self attested translation in English/Hindi. Only copies of documents attached with the original application will be considered.

- (xvii) A free 2nd class railway pass will be issued to SC/ST candidates only for attending the trial. However, no TA/DA/Accommodation will be given to any candidate for appearing in the selection trial. Applicants will have to bring their own playing kit for Trial wherever applicable. They may also be required to stay during the selection for 2-3 days, for which they have to make their own arrangements. The Railway Administration reserves the right to fix any date of trial, as deemed suitable, change place or postpone trials (at its own convenience), or even cancel trials due to unforeseen circumstances against which no claim will be entertained. Selected candidates can be posted anywhere on North Western Railway.
- (xviii) Candidature of those candidates, who fail to appear for trials and other selection procedures on the date and venue fixed for the purpose, will be cancelled without further notice.
- (xix) Candidate's admission at all stages of the recruitment will be purely provisional subject to satisfying the prescribed eligibility conditions. Mere issue of call letters for trial to the candidate will not imply that his candidature has been finally cleared.
- (xx) Specific category/post in Level-4/5 and, Level-2/3 and place of posting will be decided by the Competent Authority after finalization of panel.
- (xxi) Sports persons recommended for appointment will have to pass medical test prescribed for the post to which they have been recommended.
- (xxii) Selected candidates will have to undergo training wherever training is prescribed for the post.
- (xxiii) The sportspersons recruited as Clerk or Senior Clerk against sports quota, should pass the requisite type-writing test within a period of four years from the date of their appointment.
- (xxiv) Selected candidates will have to submit "Service Bond" of 5 years at the time of appointment.
- (XXV) All the candidates getting appointment through Sports Quota will undergo Probation Period of two years. If the performance of a person recruited on sports account is considered to be unsatisfactory, the probation period will be extended maximum up to two years and the person will have to improve his/her performance to get confirmed in appointment. Even after extended probation, if the performance is found unsatisfactory, then normal procedure will be followed for termination, before the completion of extended probation.
- (xxvi) Sportsperson recruited against sports quota shall be terminated from service, if the information and documents furnished by him/her for recruitment, are found incorrect/fake at any stage; observing requisite procedure for such termination.
