## RELAXATIONS & CONCESSIONS:

- i. Age is already in the relaxed standard, however, PwBD- Persons with Benchmark Disability/ Ex-Serviceman Candidates will be given further age relaxation as per Government of India Directives.
- ii. OBC candidates should possess a valid Non-Creamy Layer Certificate issued by the Competent Authority.
- iii. Criteria for EWS-

Persons who are not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes and the Socially and Educationally Backward Classes and whose family has gross annual income below Rs 8.00 Lakh are to be identified as EWSs for the benefit of reservation. Family for this purpose will include the person who seeks benefit of reservation, his / her parents and siblings below the age of 18 years as also his/ her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also, persons whose family owns or possess any of the following assets shall be exclude from being identified as EWSs, irrespective of the family income:

- a) 5 acres of Agricultural Land and above,
- b) Residential flat of 1000 Sq. yards and above,
- c) Residential plot of 100 Sq. yards and above in notified municipalities,
- d) Residential plot of 200 Sq. yards and above in areas other than the notified municipalities.

**The income and assets of the families as mentioned above would be required to be certified by an officer not below the rank of Tehsildar in the States/ UTs.**
