Applications are invited from gainfully employed citizens of India (male & female) for an opportunity of donning the uniform and serving the Nation as Territorial Army Officers.

1. Total Number of Vacancy. 06 - Civilian Candidates.

Note: - Vacancies are subject to change as per organizational requirement.

2. Conditions of Eligibility.

- (a) **Nationality.** Only citizen of India.
- (b) **Age Limits.** 18 to 42 years on the date of application.
- (c) **Physical Standards.** A candidate must be physically and medically fit all respects.
- (d) **Employment.** Gainfully Employed.

3. Educational Qualifications.

- (a) **Essential QR.**
 - (i) B Tech Computer Science/ Computer Engineering/IT & Telecom, B Sc (Computer Science/IT) with min 60% grades or equivalent from recognized university.
 - (ii) **Certifications in any One More Under Mentioned Fields: -**
 - (aa) Web application security and penetration testing (OSCP, OSEP, OSWA, OSWE).
 - (ab) Red Teaming Ops (CRTP, CRTE).
 - (ac) Computer Networks and Information System. (CCNA, CEH, LPT).
 - (ad) Cloud Computing (Azure A 500, AWS Cloud Security Specialty).
 - (ae) Mobile Application Development (Android), experience in Mobile development using Java/Kotlin/Flutter react Native.
- (b) **Desirable QRs.**
 - (f) M Tech in Computer Science or Cyber Security.
 - (g) Work experience in cyber field for 2 years or more is preferred.

Note: Serving members of the Regular Army/Navy/Air Force/Police/GREF/Para Military and like forces are not eligible.

4. Date of Proficiency Test & Interview. January 2024 (Firm dates will be communicated later by post/ e-mail).

5. Last Date of Receipt of Application. Application form completed in all respects will be accepted from 20 Nov 2023 till 19 Dec 2023 (05:00 PM) at Directorate General Territorial Army, Integrated Headquarters of Ministry of Defence, 'A' Block, 4th Floor, Defence Office Complex, KG Marg, New Delhi-110001 (through India Post only)

6. The Candidates to Ensure their Eligibility for the Examination. The candidates applying for the ASB Interview should ensure that they fulfill all eligibility conditions for the Interview. Their candidature at all the stages of the Interview will be purely provisional subject to satisfying the prescribed eligibility conditions.

7. Selection Procedure.

- (a) A four phase selection procedure will be followed: -
 - (i) **Phase I: Document Check.** Benchmarking of candidates will be done based on qualification for preparation of merit list & issuing call letter for written test.
 - (ii) **Proficiency Test.**
 - (aa) **Phase II: Written Test (100 Marks).** Only candidates scoring 60% and above in objective type written test will qualify for Practical Test.
 - (ab) **Phase III: Practical Test (100 Marks).** Candidates qualifying in Practical Test will be called for Interview.
 - (iii) **Phase IV: Interview (300 Marks).** Interview by Board of Offrs at Directorate General of Territorial Army.
- (b) Recommended candidates will undergo Medical Examination at Armed Forces Clinic, New Delhi followed by their Police Verification for final selection..

8. Standard and Syllabus

- (a) **Written Test.** The syllabus will consist of Network Security, Operating System Security, Cryptography and Encryption Techniques, Cyber Threat Intelligence, Incident Response and Handling, Penetration Testing, Secure Coding Practices, Cyber Laws and Regulations, Log Analysis and Forensics, Network Forensics, Audits and Compliance, Vulnerability Assessment, Wireless Penetration Testing, Wireless Networks Security, Cloud Security, Industrial Control Systems (ICS) Security, Social Engineering Attacks and Countermeasures, Mobile Application Security, Threat Modelling and Risk Assessment, Malware Analysis and Detection, Social Media Security, Web Application Security, Data Loss Prevention (DLP), Threat Hunting and Analysis and Cloud Infrastructure Security.
- (b) **Practical Test.**
 - (i) It will be conducted inform of CTF (Catch the flag) event with focus on Solving of Challenges in the domains of Threat Intelligence (OSINT), Cryptography, Web Application Security, Forensics, Reverse Engineering, Malware Analysis, Threat Intelligence and Network Incident Response etc. A candidate will participate in CTF using his/her pers laptop so each candidate has to carry his pers laptop for Practical Test.
 - (ii) Candidate will be tested for his/ Tech skills, Problem solving abilities, Time Management, etc.
 - (iii) Internet connectivity will be provided to all candidates by conducting team.

9. How to Apply. All desirous candidates can download Application Form (IAF (TA)-9 (Revised) Part - 1 & 2) from www.jointerritorialarmy.gov.in (FREE OF COST) 20 Nov 2023 onwards and send applications alongwith requisite documents to Directorate General Territorial Army, Integrated Headquarters of Ministry of Defence, 4th Floor, 'A' Block, Ministry of Defence Office Complex, KG Marg, New Delhi - 110001.

Disclaimer:- Candidates should note that no request for change of date of interview will be granted.

10. The eligible candidates shall be issued a call up letter and will be sent by the Territorial Army Directorate by post and on email.

11. Embodiment for Training.

- (a) Six months Pre-Commission Training as provided in TA Rule 20A amended vide SRO 65 dt 29 Apr 2023. (Candidates shall be commissioned in TA only on successful completion of the said Pre-Commission Training).
- (b) Two months annual training camp every year if not continuously embodied for six months in a training year (01 April -31 March).

12. Terms and Conditions of Service.

- (a) Territorial Army is part time concept with mandatory two months training in a year and does not provide full time career.
- (b) Service in Territorial Army does not guarantee pension and the same is subject to embodied service as per organisational requirement.
- (c) Commission is granted in the rank of Lieutenant.
- (d) Pay and Allowances and privileges will be same as Regular Army Officers when embodied for training and military service.
- (e) Promotions upto Lt Col by time scale subject to fulfilling laid down criteria. Promotion to Colonel and Brigadier by selection.
