#### 4. **Cut-off Date:**

The reference/cut-off date for computation of age, obtaining essential qualifications, degree, other certificates, etc shall be **01-03-2024**.

#### 5. **Application Fee:**

a. Application fee in INR will be applicable as detailed below:
